For any discrepancies, the Purchaser reserve the right to forfeit full security deposit/ cancel the order for the supply and bring the vendor on black list o the Purchaser forever. The decision of the Purchaser shall be final and binding upon the vendor.
- e) In the event of the default on the part of the vendor, in the performance of any condition of the contract and if such default is not remedied within 3 days it shall be lawful for the Purchaser to enforces full or part of the Earnest money / Performance Security and or cancel the whole part of the supply order with vendor and the decision of the Purchaser will be the final and legally binding on the vendor.
- f) Proportionate payments against supply of Goods (Toners and Drum Kit) will be made within Thirty days from the delivery date.
- g) In case of any dispute at any point the matter will be settled amicably. If the parties do not reach settlement the dispute will be referred to the Complaint Redressal Committee for Dispute Resolution.
- h) Delivery will be made by the supplier at different locations prescribed by the Purchaser.
- i) In case of failure to supply the requisite within 7 working days after the delivery time, as described under clause no 1 (b) of this agreement, Rs.1,000/- per day will be charged.
- j) This agreement is valid for a period of one year commencing from 25/11/221 to 25/11/2022 which may be extendable up to two years on mutual consent on the same terms & conditions of tender document.
- k) Supplier binds/undertakes that in case of any observation arising in respect of quality/performance of the goods within the warranty period, the supplier will be liable to address it at his own cost within 24 hours. Noncompliance of the same will result into initiation of a case against the company for no commitment and forfeiting of performance security or any other action as deemed necessary.

- If two (2) unsatisfactory letters/emails are issued by the Purchaser for unsatisfactory performance to the supplier
 - Goods Faith:

The Parties undertake to act in goods faith with respect to each other's rights under this agreement and to adopt all reasonable measures to ensure the realization of the objectives of this agreement.

Settlement of Disputes:

- The Parties agree that the avoidance or early resolution of disputes is crucial for a smooth execution of the Agreement and the success of the assignment. The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with the Agreement or its interpretation.
- If Parties fail to amicably settle any dispute arising out of or in connection with the Agreement within (10) days of commencement of such informal negotiations, the dispute shall be referred to arbitration of two arbitrators, one to be appointed by each party, in accordance with the Arbitration Act, 1940. Venue of arbitration shall be Karachi, Pakistan and proceedings of arbitration shall be conducted in English.

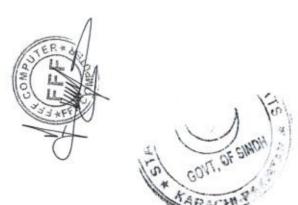
