- 3. The successful bidder will be the one who has offered the highest bid for the ATM Machines. In case if the two financial bids are the same, then the bidders will be called upon again and given a chance to offer fresh bids through open bidding process and the bid with highest offer will be accepted.
- 4. Offers shall be given on the prescribed Bid Form in a Sealed Cover Envelop marked "BID FOR DISPOSAL OF ATM Machines".

The Bid Security (In form of Pay order only, Cheques not acceptable) should be accompanied by a Pay Order/Demand Draft for an amounting to 10% of the *Total Amount in favor of "Sindh Bank Ltd" as Bid Security for each ATM Machine separately which will be refunded in case of non- acceptance of the 8id.
