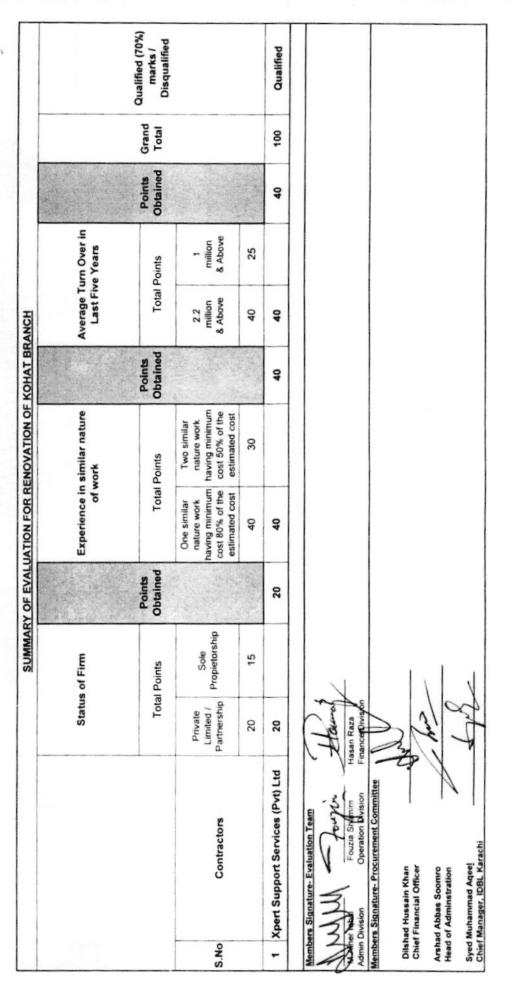

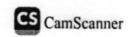

The procurement committee formulated the eligibility criteria compatible to the SPPRA Rules & Regulations.

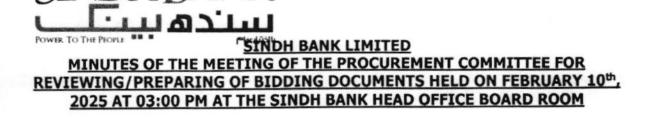

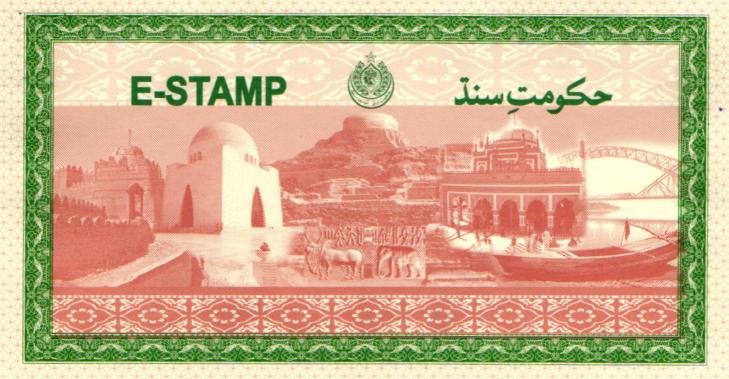
